Application Information(1-Letter of Recommendation by email, mail or drop off in p206)

- All sophomores and juniors who have a cumulative high school GPA of 3.5 or above may apply for admission to Honor Society.
- **Admission is not automatic.** In addition to having the required GPA, applicants must demonstrate significant accomplishment and/or participation in the four areas indicated on the application form. Each area is weighted equally in the application process, so it is necessary to have some accomplishments in each area.
- To become an inducted member the accepted applicant must complete a **min. of 30 service hours.**(See Community Service Hours info online) The Induction Ceremony date TBA.
- All activities, accomplishments, etc. included in the application must have taken place during high school. **Do not** include anything that occurred before you were in high school. Doing so could jeopardize your chances for admission.
- Make sure your application is neat and readable.
- All applications are read anonymously. Your name will be removed and replaced with a number. Please avoid indicating your identity anywhere in the application. Anonymity ensures impartiality and makes the selection process much easier for the committee.
- Include 1 letter of recommendation from A teacher, coach or supervisor. Letters can be sent by email or turn in to front office mail by September 7, 2018 2:46 pm.
