## REQUIREMENTS FOR ENROLLMENT IN ONLINE HISTORY FOR ORIGINAL CREDIT

1. You **MUST** be an **INDEPENDENT LEARNER: Self-Disciplined, with good organizational and time management skills.**
2. A **minimum 3.0 cumulative GPA is strongly recommended.**
3. **Online courses are not guaranteed. Classes are for students with impacted schedules.**
4. **Students must attend the required orientation meeting the first week of school or you may be dropped from the class.**
  - a. **Check your student email a week prior to the start of the semester for dates and times for the orientation meeting.**
  - b. **Pacing guides and deadlines will be discussed.**
5. **Have average to above average computer skills.**
6. **Strong internet access and a stable internet browser.**
7. **Online courses have weekly deadlines just as a traditional course and the deadlines need to be adhered to. Falling behind a unit or more may result in failing the class and or not continuing in the online course the following semester.**
8. **Working outside of the school day is necessary and expected to be successful in the course.**
